Guest(s): Emily Hoffman from Schuyler County Public Health provided a handout to the Board and spoke about updates happening within their department. These updates include Community Help Improvement Program (CHIP), Walkability Virtual Academy, and Medical Reserve Corps (MRC). Emily also handed out magnets to be prepared with a 3-day food supply and tick removal kits.

Michael Brown from Cornell Cooperative Ext. Clean Energy Communities Program spoke on different actions to take to gain points and reach goals which would then award grant money to the Town. The town could send Building Inspector Rick to a training and pass two different resolutions that Mike will email to Supervisor Scott. This would earn the Town enough points to be awarded a \$5,000.00 grant to be used towards sustainability and clean energy projects.

Report of Town Officials and Committee Members:

<u>HIGHWAY:</u> Superintendent Bailey informed the Board that, with help from Town of Hector and other neighboring towns, Cass Rd. has been shouldered. Also, our guys have put up new signs along Cass Rd. Bailey would like to move the 9-ton posted sign to the State Road, that way it is visible to the truck drivers

before turning onto Cass Rd. Bailey will reach out to the State to see if he can move the sign. Bailey also reported that there are a few spots on Wicks Rd. that were boxed-out. Wicks Rd. will be chip sealed and the boxed-out spots will be double coated. Havana Glen Rd. will also be chip sealed. Fitzpatrick Hill Rd. has a couple areas where the edge drops off, those are going to be fixed soon. The Town's bridge application for Fitzpatrick Hill Rd. was approved for \$2,113,000.00 but construction is not expected to start until 2025.

Havana Glen: Up \$1,109.¹⁴ from 2022. Supervisor Scott informed the Board that Kristin VanHorn, the County Planner, has submitted our project plans to NYS Consolidated Fund under Parks & Recreation for our Park Project. We should hear back on this in late fall or early winter. The total cost was \$679,736.⁰⁰ and the Town's share would be \$179,736.⁰⁰. Gloria also informed the Board of verbal complaints that have brought to her attention through the Park Manager regarding the Adult Softball League that uses the Park's ball field on Sunday. Among these complaints are loud music, smoking, drinking, drunk people, cussing, arguing and fighting. The Board agreed that Gloria will email the league president and let him know of these complaints and that we will be discussing the use of our field for the 2024 season at a future Board Meeting.
